

## Contract for Consignment

Please read the consignment info thoroughly. If you have been contacted please fill out this form and bring it in signed.

### Some helpful hints for Consigners

- Please do not undersell us at shows or at other locations. This does not make for a good relationship and is not a good business practice. To summarize please keep your prices consistent.
- Submit an inventory and price list with your work. If anything needs to be changed at time of drop off to the store any changes will be signed by you and us. Sometimes we may not be able to take everything you bring in,
- Supply testers or a floor model. Remember customers are not always the most considerate of your creations. If anything needs special packaging at point of sale please provide. We provide general packaging such as tissue and bags. If anything has special care instructions, ingredients etc please make sure the product is appropriately labeled.

### Agreement

1. *Frayed Around The Edges* agrees to sell on consignment, the items listed on the inventory sheet supplied by the undersigned artist. Additional sheets may be incorporated into this agreement if signed by all parties.
2. The artist's work will remain on consignment *with Frayed Around The Edges* for a minimum of 30 days. At the end of 30 *days Frayed Around The Edges* reserves the right to either:
  - a) keep the artist's unsold merchandise on consignment for an additional 30 days or
  - b) return any unsold merchandise to the artist.
3. *Frayed Around The Edges* reserves the right to remove work for whatever reason they may choose. We will give two weeks notice to artist, discussing the removal of creations or the possibility of price reduction. The artist may remove creations with two weeks notice to *Frayed Around The Edges* at any time. If you need to pull creations for working an outside event give us the 'Heads Up' before hand (schedule it).
4. Payment will be made available to the artist the beginning of each month. If the amount owed to the artist is less than \$20 payment will automatically roll over to the next month's pay cycle. You will receive a list of what sold during the month along with your payment.
5. Inventory updates will be made upon the artists request.

6. *Frayed Around The Edges* will do it's best to promote, display and sell your work. You as an artist agree to keep *Frayed Around The Edges* supplied with your creations.
7. *Frayed Around The Edges* agrees to pay the consignor 50% of the wholesale price listed on the inventory sheet in the event an item is stolen or damaged. In other words if an item is stolen or damaged we will split the cost with you.
8. It is your responsibility to deal with the TAXMAN.
9. The split is 45-55. We take 45% of sale and you will receive 55%. Remember this when pricing.
10. *Frayed Around The Edges* does not provide insurance for consignor's creations that is the individual artists responsibility. We have our own insurance so should you.
11. We do not cover shipping expenses of creations. If an artist chooses to ship their creations to the store/customer it is at their own expense.
12. *Frayed Around The Edges* seldom has a store-wide sale but if so you will be contacted on whether you wish to participate.
